1. How will the LEA, to the greatest extent practicable, support prevention and mitigation policies in line with the most up-to-date guidance from the CDC for the reopening and operation of school facilities in order to continuously and safely open and operate schools for in-person learning?

The health and safety of the Admiral Peary Vocational-Technical School (APVTS) and the staff and students remain, as always, the top priority for the organization. The (APVTS) will continue to take critical steps making decisions that protect the health and safety of our organization in the ongoing response to the COVID-19 pandemic.

In response to the expiration of statewide mitigation orders, APVTS has identified organizational standards and expectations which outline the protocols expected of all staff members as the organization transitions forward. Protocols include the following:

- Self-screening for COVID-19 symptoms
- Following communicable disease reporting procedures
- Practicing hand hygiene and respiratory etiquette
- Optional use of face coverings / adherence to health and safety plans of locations served
- Cleaning and disinfecting one's workspace
- Maintaining physical distancing protocols to the maximum extent feasible
- Staying informed of CDC's guidance relative to travel
- Monitoring communication and confidentiality
- Participating in required training
- Staying informed and maintaining best practices

2. The first revision, July 29<sup>th</sup>, 2021 expectations are based on the latest mandates issued by the Governor's Office, the Pennsylvania Department of Health (DOH), the Pennsylvania Department of Education (PDE), the Department of Human Services (DHS), and the Centers for Disease Control and Prevention (CDC). APVTS will continue to monitor communications. As conditions change related to COVID-19, protocols are subject to change.

- ❖ ***The current revision***, 12-10-21, states the following: On Friday, December 10th, the PA Supreme Court affirmed the order of the PA Commonwealth Court which had vacated the Face Covering mandate issued by the PA Department of Health in August. **Therefore, starting Monday, 12/13, although recommended, masks are optional in all Admiral Peary Vocational-Technical School buildings and classrooms. However, masks remain mandatory on all school buses** in the United States based on the federal order which remains in place until we are informed otherwise.

Please note that the quarantine guidelines are significantly stricter when students are not wearing masks. Quarantine and isolation requirements also vary when factoring vaccination status or having developed natural immunity from a documented COVID-19 infection within the past 3 months. Therefore, students and staff who wish to continue to wear masks at Admiral Peary AVTS, are welcome to do so.

3. How will the LEA ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services?

APVTS will ensure access to remote learning opportunities for all our students in the following ways, including but not limited to: Live synchronized lessons and demonstrations by our teachers -Additional asynchronous lessons and student assignments via Google Classroom and/or other similar platforms. Paper packets will be utilized as a last resort.
